A conflict of interest is any situation in which a trustee/governor's personal interests or loyalties to another person or organisation could be seen to prevent a decision being made in the best interests of the school/academy. **NB:** *It is the responsibility of individual governors/trustees to inform the relevant person at the school/academy of any changes in their business or personal interests so this grid can be amended accordingly and dated. **If in doubt, declare!***
